The Stanton County Board of Commissioners met in regular session February 5, 2024. Present were Commissioners Lonnie Brown, Chris Floyd and John Smith, County Attorney Clint Floyd, and County Clerk Sandy Barton. Chairman Brown called the meeting to order at 8:30 a.m.

District Court Clerk Gwendolyn Olivas met to update them on State reimbursement of the required updates mandated by the Official Judicial Administration. The OJA has not provided any further information yet.

He continues to investigate a new program for the department that also includes GIS capabilities. He will try to schedule a webinar at the next meeting. The department continues to work on roads.

County Treasurer Vanessa Trujillo met with the Board to discuss some delinquent taxes. Frazee Abstract would like the Board to forgive interest and fees on some 2016 taxes that were not on the Treasurer's website for taxes. Vanessa let the Board know she had previously sent a list of delinquent taxes at the end of last year which included these 2016 taxes. Commissioner Floyd moved to not forgive the interest and fees, seconded by Commissioner Smith. Motion carried 3-0.

Sheriff Kester met with the Board to update them on his department. He let the Board know that Dispatcher Keen resigned. Stanfield continues to work on the new roof. Clayton will get bids to replace tiles in the garage and update the guttering on the building.

The Board called Lettie McKinney who is requesting permission to apply for a county caterer license since she is located outside the city limits. Commissioner Floyd moved to grant her permission to apply for the license, seconded by Commissioner Smith. Motion carried 3-0. County Clerk Sandy Barton will fill out the County portion as requested.

The Board signed a letter of support for the City of Johnson to apply for the Raise Grant for funding of re-doing Highland Avenue.

Chairman Brown signed the Mowing Agreement between the County and Circle 6 Farming & Mowing LLC.
