

July 18, 2022

The Stanton County Board of Commissioners met in regular session July 18, 2022. Present were Commissioners John Smith, Chris Floyd & Lonnie Brown, County Attorney David Black and County Clerk Sandy Barton. Chairman Smith called the meeting to order at 10:00 a.m.

Minutes of July 5 & July 15 were read and approved.

Road Supervisor John Schweizer met with the Board to discuss issues pertinent to his department. John informed the Board the interest rate increased on the motor grader since it was over the 120-day lock-in. The Board requested him to check with the local banks for financing the motor grader.

County Attorney Black left the meeting at 11:30.

Health Nurse Ruth Walker met with the Board to discuss the June financials for the Health Department. Ruth submitted an Active Transportation Plan for Stanton County. The Health Coalition continues to work on the walking path at Battin Park. Ruth is looking into the purchase of a container for storage and a new Website for the County, to be paid for by COVID monies.

EMS Director Roger Richardson and Nicole Edmisson met with the Board to discuss charges for ambulance runs. After a discussion it was decided to raise the mileage rate by \$2.00 and the run rate by \$200. It was also discussed paying above the run rate of \$30 for a local run when the call lasts for more than 2 hours. No decision was made at this time.

Custodian Mitch Grover met with the Board to discuss his job duties. The weekly duties list will be re-done. It was also discussed about the mileage they are driving per month going back and forth to the different buildings. They are to keep track of their mileage and the Board will decided on reimbursement later.

County Treasurer Vanessa Trujillo met with the Board to give an update on outstanding taxes to be collected and the current County financials.

County Clerk Sandy Barton visited with the Board about Deputy Clerk Amber Wilkerson and requested her wage to be increased by \$1.00. The Board approved the request.
